ARTICLE SUBMISSION GUIDELINES

There are no fees for submission of articles or publication of articles. The Journal of Criminal Justice Professionals is a refereed non-profit journal with specific focus on criminal and juvenile justice issues. It provides a forum for practitioners to not only learn and share information with each other, but also an opportunity to remain current with the latest trends in the discipline. The journal specifically encourages the exploration of ALL sides of situations and events occurring in criminal and juvenile justice. The editors accept conceptual articles, research articles or notes, book reviews and discussion pieces.

### **Editorial Policy**

An anonymous peer review process is used. Author's names and affiliations are removed from the article prior to sending to a reviewer. The reviewers are also anonymous to the author. Two reviewers will read the manuscript and submit a review from to the editors. If there is disagreement among the two reviewers, the manuscript will be reviewed by an editor or editorial board member. Decisions are made within 4 – 6 weeks after submission.

### **Authorship**

All contributing authors should be listed on the manuscript. Because the contact author is always the lead author, it is important to include the specific contact information for the contact author. Each contributing author is required to sign a journal contributor's publishing agreement. This agreement provides the Journal of Criminal Justice Professionals exclusive right and license to publish the full legal term of copyright in the work.

### **Manuscript Submission Guidelines**

Powered by Formsite.com a web based online submission and peer review system. Authors should download a copy of their manuscript at <http://?????>

Contact information and affiliations for all co-authors with the identity of the contact author should be on the title page. All acknowledgements and declaration charts and tables should be included at the time of the online submission

Manuscripts must be edited and ready for publication at the time of review. All permissions must have been obtained prior to submitting.

Manuscripts should be 20 – 35 pages in length (does not include abstract and reference pages). The style should adhere to APA style using the APA 6<sup>th</sup> edition manual as a guide. All charts, tables, and graphs should be inserted in the appropriate space and not included as an appendix.

The editors will keep authors informed of the status of the review process of the manuscript.

If, during the review process, there are changes in the manuscript and or authors, each author must sign a form authorizing the change. Proofs will be sent by PDF to the contact author and should be returned within the specified time period. Proofs should be carefully checked to ensure that all author's information is accurate. Publication is not the end of the process. Dissemination of the article to maximize your article's impact.
